**ACCEPTANCE PROCEDURE:** All business plans are subject to review and approval and Illinois Business and Investors Forum has the right to reject any entrepreneur registration or application for any reason. A full refund will be granted for denied applications. In addition, following posting of your business plan, Illinois Business and Investors Forum reserves the right, in its sole discretion, to cease to post your business plan, and will refund you a pro rated portion of your fee, unless Illinois Business and Investors Forum has determined, in its reasonable judgment that (i) your business plan was not submitted in good faith with the intention of attracting investment from angel investors, venture capitalists or similar investors or (ii) your business plan contains material misstatements or material omissions which make it materially misleading to potential investors, in which case you will not be entitled to a refund.
